SPECIAL INSTRUCTIONS	
<ol style="list-style-type: none"> 1. The owner of record is responsible for the complete removal and completions of the required sewer, water, electrical and gas disconnects. All such work must be accompanied within five (5) days of removal of the structure. 2. Private sewer lines connecting to the public sewer must be disconnected and capped, with a City inspection prior to the covering of the trench. 3. Water meters must be removed by the water district jurisdiction; contractor is required to notify jurisdiction a minimum of 24 hours in advance. 4. Private sewage disposal systems must be pumped out and removed or filled with sand and inspected. 5. Work related to this Permit Application may be subject to regulations governing the handling, removal and/or disposal of asbestos and/or lead-based paint. 	
CONTRACTORS REQUIREMENT	
Contractor is expected to notify the Building Division at 503-489-6861 a minimum of 48 hours in advance of removal or demolition.	
The City of Wood Village will notify any applicant of any potential hazards regarding traffic and the safety of structural removal. Contractor and the property owner will be responsible for any safety equipment personal requirements. Any request to remove structures through fire training exercises by burning structures will require approval from Gresham Fire Department.
